SET UP

Parkland:

- As of Friday, August 11 at 0700 hrs:
 - o Dr. Wilbert MacIntyre Park; and
 - o Lighthorse Park

Roadways:

- As of July 24 at 0700 hrs:
 - CP Rail Lands use as staging grounds for Event set up
- As of Friday, August 11 at 0700 hrs
 - Full closure of 104 Street Service Lane from 82 to 86 Avenue
 - Full closure of 83 Avenue from Calgary Trail to Gateway Boulevard including the bike lane
 - Full closure of 84 Avenue from Calgary Trail to Arts Barns including Service Alley between 84 & 83 Avenue
 - Full closure of 83 Avenue parking lots including the lot north of El Cortez (lot 5066) and the lot east of the Westbury Theatre (parkland)
 - The alley between 82 & 83 Avenue and 104 and 103 Street to remain open to east/west vehicle traffic given business servicing and parking access.
 - A pedestrian access point to be maintained between the Fringe licensed area and the alley leading to the back alley businesses (Sugared & Spiced Bakery)
 - o Full closure of 85 Avenue from Calgary Trail to alley will leave access for businesses
- As of Friday, August 11 at 0500 hrs:
 - Travel lane closure on the west side of 103 Street from 82 to 85 Avenue including the parking lane from 83 to 84 Avenue (set by Traffic Operations)
 - Street sign fixture removal on 83 Street from Calgary Trail to Gateway Boulevard and 84
 Avenue from 104 St to alley (by Traffic Operations). Map to follow.
 - Full closure of the alley between 103 & 104 Street north of 85 Avenue to the Light Horse Park entrance/youth shelter fence line including the Light Horse Park southeast corner parking stalls. (set by Traffic Operations)
 - Closure of parking stalls along the west side of the 104 Street service lane (next to active traffic) between 82 to 83 Avenue
- As of Friday, August 10 at 0700 hrs:
 - The following areas are to be defined as loading zones for the operations of the OSBA.
 Some locations to be shared use with ETS/DATS/Free Fringe Shuttle. NOTE: the west lane of 103 Street between 83 Avenue and 85 Avenue will be closed during the Event.
 - Northbound east parking lane on Gateway Blvd north of 82 Avenue. EPark Zone 5013a.

Getting to Fringe

ALTERNATE TRANSPORTATION

In partnership with Edmonton Transit Service and the Edmonton Radial Railway Society, Fringe enthusiastically encourages Fringers to find neighbourhood-friendly ways to get to and from the site, including:

- **Biking:** bike parking lots are available around the Old Strathcona neighbourhood, but be sure to bring your own lock!
- *Edmonton Transit Service:* Edmonton Transit in our transportation of choice for getting to Fringe! Routes 004, 008, 404, or 701 will get fringers close to site.
- *High Level Street Car:* the historic High Level Street Car runs daily during the Festival on an extended schedule. Please visit edmontonstreetcars.ca for schedule details.
- **Free Fringe Shuttle:** the Fringe Shuttle returns this year! This free service takes fringers from the main site to the French Quarter and back again. The Shuttle departs on the hour and half hour and will run daily during the following hours:
 - Thursday, August 17: 8pm 12Midnight
 - Friday, August 18 through Saturday, August 26: 12Noon 12Midnight
 - o Sunday, August 27: 12Noon 8pm

NEIGHBOURHOOD SIGNAGE

Again this year, we will post signage in areas immediately adjacent to our site to encourage Festivalgoers to love our neighbours. These signs include reminders to:

- Park in public lots;
- Keep noise to a minimum; and
- Throw trash in bins.

NEIGHBOURHOOD RENEWAL

The Strathcona Neighbourhood Renewal construction schedule has adjusted timing to work together with festivals to ensure festivals have the appropriate space and public access.

There will be limited on-street parking available through Old Strathcona so the City and festivals will be encouraging attendees to use other modes of transportation to attend Festivals including public transit. Please check the ETS Trip Planner in advance to plan your route.

COMMUNITY CARE TEAM

Community Care is Fringe Theatre's service-based program comprised of Volunteers and Staff using harm reduction approaches to community crisis response and community empowerment. This team supports unhoused and vulnerable community members who may access various community supports in the immediate vicinity of the Fringe Theatre Arts Barns and Fringe Festival grounds who are often displaced from their regular use of public spaces by Festival activity. This is a situation that has arisen not by design but as a matter of circumstance. Our Community Care team continues to evolve and respond to emerging community needs thanks to vital supports from organizations who lead this important work like Boyle Street Community Services, Bissell Centre, The Mustard Seed, Youth Empowerment and Support Services, Old Strathcona Youth Society, 4B Harm Reduction Society, and more. We could not do this work without their expertise, experience, and resources. We are grateful for the very many ways these organizations serve community and uplift organizations like Fringe Theatre in this work. The Community Care engages with community the week before and during site setup, throughout Festival, and during strike.

STRATHCONA RECYCLING DEPOT

The City of Edmonton is responsible for the temporary relocation of the recycling bins on the south side of 85 Avenue, east of 104 Street.

Edmonton Fringe will continue to meet with Good Nieghbours and the City of Edmonton Civic Events Office to discuss future planning and debrief following this year's Festival.

Good Neighbourhood Plan Terms of Reference

The City of Edmonton and the Multi-Day Festivals held in the Old Strathcona area are committed to developing a good relationship with the surrounding resident and business community and the citizens of Edmonton at large.

The City of Edmonton promotes the celebration of diversity, milestones, achievements and festivals - and supports creating opportunities for celebration and the tradition of hosting events in all seasons, for all ages.

All stakeholders are committed to establishing a mutually beneficial and respectful relationship.

Purpose

The purpose of the Good Neighbours Plan is to act as a foundational document to define the high-level commitment of all stakeholders for Multi-Day Festivals in Strathcona, outline each party's working relationship and identify the principles of the working relationship including the process for addressing potential challenges and acknowledging successes.

Stakeholders & Working Relationship

The stakeholders include:

- Multi Day Festival Event Organizer
 - o Ice on Whyte
 - o Edmonton International Fringe Theatre Festival
 - o Edmonton International Street Performers Festival (interim only)
 - Whyte Avenue Art Walk
- City of Edmonton
- Strathcona Community League, Community and Neighbourhood Committee
- Old Strathcona Business Improvement Area

All Stakeholders commit to working collectively to champion successes and minimize impacts on the surrounding community, acknowledging the scope and scale of the Multi-Day Festival and their service to Edmonton as a whole.

This document will be reviewed in the fall of each year to confirm the working relationship of the stakeholders listed. The stakeholders agree to the following principles:

- To meet bi-annually (spring and fall of each year)
- Promote open lines of communication
- Seek and take perspective of the other stakeholders
- Work collaboratively to address concerns of the stakeholders

General Terms

Each stakeholder as we move through the annual multi-day festivals planning and implementation process agree to the following:

• City of Edmonton

- Approval of festivals and events use of City of Edmonton property with feedback and consideration of other stakeholders
- Oversight / overview of City related components (e.g. licensing, permits, civic service coordination, etc)
- Before new multi-day festivals are approved for the Strathcona area, community consultation will be conducted to gather feedback.
- Provide a Strathcona event calendar that lists both multi-day festivals and community celebrations and events to all stakeholders by February 1. The calendar will be continually updated on an ongoing basis as event applications are processed. It is understood that event calendar is subject to change and elements may be considered confidential.
- o Providing additional support on event days, as required (e.g. command)
- Being available to receive feedback from community members and communicate this feedback through the set channels
- o Responding in a timely fashion to feedback from community members
- Identify/pursue shared benefits
- Multi Day Festival Event Organizer
 - Work with community league to develop relationship and ensure consistent and open communication
 - Work with the BIA to develop relationships with local business and potential partnerships and ensure consistent and open communication
 - Distribute formal event notification to residents and businesses impacted a minimum of 2 weeks before their event - to be reviewed by the City of Edmonton prior to distribution. Mechanism and boundaries for notification will vary between festivals depending on their area of impact and will be circulated for information to the community leagues and approved by the City of Edmonton.
 - o Share high level production schedule with the community league for information
 - Maintain a secondary appendix to this plan to outline the specific mitigation strategies employed and desired outcomes (see Community Appendix section for more information)
 - Continually explore mitigation strategies to address concerns
 - Being available to receive feedback from community members and communicate this feedback through the set channels
 - o Responding in a timely fashion to feedback from community members
 - Identify/pursue shared benefits
- Community League Community and Neighbourhood Engagement Committee
 - Engage community in providing feedback (pre and post event)
 - o Share information with neighbours (e.g. social media, newsletters, CL website, etc)
 - Represent the community as a whole
 - Use all reasonable mechanisms at its disposal to additionally communicate the event calendar to residents, such as league meetings, website, newsletter, etc.
 - Advise the community of opportunities to become a part of the festival (volunteering, fundraising, etc)

- Being available to receive feedback from community members and communicate this feedback through the set channels
- Bring forward, well in advance of the event, top or key community priorities
- Identify/pursue shared benefits
- Business Improvement Area
 - Support the multi day festival event organizer in building business relationships
 - Being available to receive feedback from business or community members and communicate this feedback through the set channels
 - Offer online event calendar
 - Identify/pursue shared benefits

Secondary Appendix

Each multi-day festival identified will develop a secondary appendix that outlines the specific mitigation strategies related to community and business concerns. The document will track and prioritize high level concerns, provide details on the mitigation strategies employed, evaluate successes and help determine next steps for future years. The document will seek to be an ongoing and historic record of efforts and will be shared with all stakeholders. It is acknowledged that as new impacts arise they will be discussed, prioritized, and addressed when possible by the stakeholders.

Mitigation strategies may be developed around the following (including but not limited to):

- Traffic Disruptions
- Parking
- Noise
- Waste Management
- Community notification
- Emergency & Public Safety Plans to address disruptive attendee behaviour
- Other as needed

Definitions

- Multi-day festivals: include, but are not limited to organized public gatherings which occurs on, or impacts, City of Edmonton property (owned, leased or controlled by the City), which last for a fixed duration over 3 days and have an attendance expectation exceeding 10,000 guests; festivals and events requiring added civic service plans with an expected impact on the community; etc.
- Community celebrations and events: include, but are not limited to organized public gatherings celebrating a sporting, cultural, community or other type of unique occasion or theme, which occurs on, or impacts, City of Edmonton property (owned, leased or controlled by the City), which lasts for a limited or fixed duration; events within this scope include but are not limited to runs, walks, parades, processions, weddings, as well as small to medium special events; an activity that can be conducted with "regular" operations and civic services plans, and is not expected to have undue impact on the community; etc.
